
In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43, dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of **Shri Charanpreet Singh, S/o Late S. Mohan Singh, Ex-Senior Mechanic, R/o Kalasy Chak, Tehsil Marh, at present House No. 30, Aman Vihar, Phase-II, Camp Road Talab Tillo, District Jammu, as 'Fieldman' in the Pay level-2 (Rs 19900-63200)** on compassionate grounds against available vacancy of direct recruitment quota in the office of Agronomist, Vegetable Improvement Scheme Jammu.

The appointee shall report to the Agronomist, Vegetable Improvement Scheme, Jammu alongwith the following original certificates / documents to be verified subsequently for further duties within 21 days from the date of issuance of this Order. In case, he does not join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.

1. Permanent Resident/Domicile Certificate.
2. Academic Qualification Certificate (10+2 & above).
3. Age & Health Certificate.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Any other Certificate as required under rules.

The appointee shall be initially on probation for a period of two years. If, on verification at any stage, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Additional Director General of Police, (CID), J&K.
