
C I R C U L A R

- 1) The seniority list may be displayed at prominent place on the Notice Board and shown to each of the officials working in their scheme/office/district to make them aware of their seniority position.
- 2) The concerned officials may file their objections, if any, in respect of their seniority position with authenticated proof/supporting documents within a period of 21 days from the date of issue of tentative seniority list.
- 3) The aggrieved employee may submit his representation through his controlling officer with an advance copy to this Directorate on official email within the prescribed time limit.
- 4) All representations received from the officials regarding discrepancies may be forwarded to this Directorate by the concerned controlling officer with his comments clearly supporting or contradicting the claims.
- 5) The date of birth as has been recorded in the seniority list will not be taken as authentic unless it is properly supported by the proof authentication in this regard.
- 6) Copy of the seniority list duly signed by each of the officials who have no objection to it be furnished to this Directorate.
- 7) The Objections received after stipulated date shall not be considered.

Further, the concerned controlling officers shall furnish the following documents of the Section officers for onward submission of their case to Administrative Department for further incorporation of their seniority in the common seniority list of Section Officer (HODs).

- a) Photocopy of the complete service book duly attested by the concerned DDO.
- b) First appointment order of the concerned incumbent alongwith the copies of orders of promotion right from initial appointment to the post of Section Officer.
- c) Date of Birth Certificate duly attested by the DDO.
- d) If, concerned incumbent is "Secretariat Assistant Training Course" qualified, provide the Marks sheet duly attested by concerned DDO.
- e) Academic qualification certificates duly attested by concerned DDO.
