The adjustment of the officers shall not confer any right on the transferees to hold the post on substantive basis. Besides, the adjustment shall be:-

- Temporary and purely to look after the assignment and shall not confer any right on the officer to hold the post on substantive basis nor shall it be determinative of inter-seniority position of the officer;
- Without prejudice to the outcome of the writ petitions pending before any competent court of law. The officer shall be considered for regularization under rules for the higher posts only on the basis on the recommendations of the DPC/PSC based on which his/her seniority positions at the substantive level shall be determined.
- Reversible any time without any notice to the officer as may be deemed fit in the interest of administration.
- With a view to rationalizing the drawal of pay etc. and the officer will be entitled to draw his/her salary in accordance with the rules against the post where he/she is posted which shall and shall be, purposes of drawal of the salary only. He/she shall, however, continue to retain his lien on the substantive post held by him/her.


