Sub: - Attention all Kashmir Migrant Govt. Employees of Agriculture Production Department, drawing salaries from the Directorate of Agriculture, Jammu.

WHEREAS, as per the standing Government instructions/orders, all Kashmir Migrant Govt. Employees are required to remain present at the Headquarters of the Office(s) from where their pay is being drawn and the concerned Drawing and Disbursing Officer is required to ensure the following on regular basis for drawal of monthly salaries of Migrant Employees.

- i) That the Migrant Govt. Employee is alive;
- ii) That the Migrant Govt. Employee is residing at the Headquarters or nearby; and
- iii) That they are not doing any private business/occupation.

WHEREAS, all Kashmir Migrant Govt. Employees of the Agriculture Production Department, who are drawing salary from the Directorate of Agriculture, Jammu are also required to attend this office and sign the pay acquaintance roll upto 20th of every month failing which their pay for the next month can't be drawn by this Directorate;

WHEREAS, reports have been received that some Kashmir Migrant Employees, drawing migrant salary from this Directorate are illegally engaged in private businesses/professions/occupations thereby making them liable to face disciplinary proceedings under Govt. Service Rules which may range from various administrative actions against them including dismissal from Service;

In view of the above mentioned facts, all Kashmir Migrant Govt. Employees of the Agriculture Production Department, who are drawing their migrant salaries from this Directorate, are advised to immediately report to the Director Agriculture, Jammu by or before 23rd of August, 2019 upto 04:00 PM, along with an Affidavit sworn before 1st Class Judicial Magistrate stating therein that they are not engaged in any private business/profession/occupation and that they are putting up at Jammu or nearby, failing which their salary for the month of July and onwards shall not be drawn, besides sending their cases for verification of their status vis-à-vis their engagement in any private business/other profession and present place of stay from the C.I.D. wing of J&K Police, wherever felt necessary.

Besides, this Directorate is also contemplating to assign suitable duties to the Kashmir Migrant Employees who are drawing salary from this Directorate.


