AT SMF KOTLI MIAN FATHA**





On Inspection of field it was observed that Mixed Fodder Crop has been sown in area of 4 Kanals at SM Farm Kotli Mian Fateh. The said crop is ready for use as Fodder and the crop has attained desirable height and is fit for auction as requested by Farm Manager.

Keeping in view the high demand of Mixed Fodder crop and in order to realize the matching revenue, it is high time to auction the Fodder crop mentioned above to make available for the next crop by conducting open bid auction proceedings at the earliest possible preferable date as per auction schedule proposed by the concerned Farm Manager for which wide publicity be ensured in and around the farm vicinity adhering to the prescribed codal procedure or whatever deems fit to the Auction Committee at the time of Auction proceedings as assessed and the interacted on spot at the farm. 
