**Terms And Conditions**


- 1 The tenders should reach the office of the undersigned by or before 25/09/2017 by 02.00 P.M through speed post / courier/ by hand. Tenders brought by hand shall be put in a TENDER BOX by the concerned tenderer in the office of the undersigned on any working day during office hours up to the said date and time. In case of any gazetted holiday falling on the last date of receipt of tenders or some holiday suddenly declared by the competent authority under Negotiable Instrument Act , the next working day shall be treated as the last date of receipt of tenders
- 2 The under mentioned documents / detail must be submitted with the tender
  - A. Registration Certificate of the firm.
  - B. CDR/FDR for an amount of Rs.5000/- Pledged to Accounts Officer (Member Sectary Department of Agriculture J&K Govt. Talab-Tillo, Jammu
  - C. Literature/ Catalogues of relevant items.
  - D. Copy of PAN card and Copy of Income Tax Return for the year
  - E. Dealer ship certificate of Principal
  - F. Valid GST Registration Certificate
- 5 The tenders should be accompanied with a C.D.R. for amount of Rs.5000/- on any scheduled bank and pledged to Accounts Officer Department of Agriculture, J&K Govt., Talab Tillo-Jammu.
- 6 Supply should be made by successful tenderer within 20 days from the date of confirm supply order.
- 7 The tenders should be neatly written in ink with rates in figures and words. Cutting or overwriting on quoted rates shall not be entertained unless authenticated. Cello tapes be applied on the written rates of tender.
- 8 The tenders will be opened by the Divisional Level Purchase Committee (DLPC) on the same day, or any other working day convenient to the members of the Committee, in presence of tenderers or their representatives who wish to remain present at the time of opening of tenders
- 9 DLPC reserves the right to accept or reject any tender, part of the tender , or all the tenders without assigning any reason thereto.
- 10 Any condition of **PAYMENT IN ADVANCE** shall not be accepted.
- 11 Conditional tender shall not be entertained.
- 12 Rates shall be quoted by the tenderers against each item as given in Performa and should be exclusive of GST

- 13 The successful tenderer shall have to deposit 5% of the total tendered value in the shape of "Deposit at Call" in any Nationalized bank having branch at Jammu duly pledged to the Joint Director of Agriculture (Slub) Talab-Tillo Directorate of Agriculture Jammu , as security money within the stipulated date given by the authority after acceptance of rate if the successful tenderer fails to deposit security money within the stipulated date , the tender shall be treated as invalid and rejected and earnest money deposited shall be forfeiting . Supply order will be issued on receipt of security money.

- 14 Security money will be released after completion of supply order. The Part of supply or incomplete supply or deviation of specification will also invite forfeiting of security money.
- 15 The successful tenderer shall have to supply the Items strictly within the time schedule to be given by the department. In case of failure to make the supply in time, the department shall be at liberty to arrange the same at the risk and cost of successful tenderer besides forfeiting the C.D.R, and initiating legal proceedings against the successful tenderer (s) as warranted under rules. In case, the extra cost involved exceeds the CDR amount, the same will be recovered from the defaulting supplier through Land Revenues Act . The decision of the Chairman D.L.P.C Agriculture department Jammu in this regard shall be final and binding upon the supplier. The supplier shall have no right to claim such refund at all.
- 16 The Equipments for weather station supplied if not found up to the standard , or any other shortcoming shall be rejected out rightly and shall have to be replaced by the supplier at their own cost and arrangements within seven days from the date of intimation.
- 17 Supply should be completed within ten days from the date of receipt of supply order
- 18 100% payment shall be made by the department after receipt of satisfactory supply
- 19 The successful tenderer shall have to enter into an agreement on prescribed Performa on non judicial stamp paper of Rs.20/- with the indenting officer before the supply order is issued in his favour for effecting supplies.
- 21 Rates approved by Divisional Level Purchase Committee shall remain valid for one year from the date issue of minutes of meeting or till the next rate contract is available.
- 22 Doubts/ Disputes/ Differences arising out of contract entered between the parties will be referred to the Chairman D.L.P.C Agriculture Department Jammu for decision under J&K Arbitration Act, whose decision should be final and binding on both parties.
- 23 All other terms and conditions laid in financial Code J&K regarding supplies/procurement of stores in Government department shall be applicable.
- 24 Legal proceedings, if any, are subject to the jurisdiction of the courts located in the Jammu city, of J&K State
