In case the date of receipt of the tender is declared as a holiday or condition remained disturbed for any reason, the tender shall be received on the next day upto 04.00 PM.


1. Supply/cost of good earth filling in platform not exceeding 20 cm in depth consolidating each deposited layer by ramming and watering for 910.00 cum.
2. Re handling of earth available for filling 40% of 910.00 cum i.e. 364.00 cum for levelling the platform in good shape by manual or by mechanical means.

**Terms and Conditions**

1. The tender should be accompanied with CDR of Rs.14000/- from any scheduled bank pledged to Accounts Officer (Member Secretary) SLPC Directorate of Agriculture Jammu.
2. The rates quoted should be covered with transparent tape. Correction, if any should be authenticated by signature.
3. The successful tenderer shall have to start the work within 3 days after the date of issue of letter of indent or allotment, failing which action under rules shall be taken against him.
4. The contractor will not be allowed to sublet work to any other agency.
5. The tender should be sealed in an envelope with name of the work **Super-scibed. Filling of good earth for establishment of naturally ventilated Poly Green house**
6. The tender opening authority reserves the right to accept or reject any or all tenders without assigning any reason thereof.
7. In case the successful tenderer fails to start execution of the work within three days after issuance of allotment / letter of indent, the work shall be got executed through some other agency or means at his risk and cost without issuing any notice or reminder.
8. The successful tenderer have to execute the job within 15 days from the date of issuance of allotment / letter of indent.



9. The tenders will be opened by the Statel Level Purchase Committee on the same day, or any other working day convenient to the members of the Committee, in presence of tenderers or their representatives who wish to remain present at the time of opening tenders.
10. The tenders should be neatly written **in ink** or computerized typed. The rates shall be quoted both in words as well as in figures against each item by the tenderer. Cello tapes be affixed on the rate quoted by the tenderers.
11. The successful tenderer shall have to supply the material within 15 days from the date of issuance of allotment / letter of indent or within a time schedule given by Department as per the issuance of allotment / letter of indent.
12. Payment shall be made only after receipt / verification of materials by the committee constituted by the department.
12. T.D.S as applicable under rule shall be deducted by Indenting Officer while making payment.
13. After opening of bids if it is detected that rates quoted are not reasonable, SLRCFC reserves right to go for negotiation / re-tender.
14. Copy of electric tariff clearance ending Sep.2015, issued by Power Development Department shall have to be produced by successful tenderers before release of payment by Indenting Officer. But this condition is not applicable for outside state firms.
15. The tenderer, along with its quotation, must also submit a certified copy of its latest income tax clearance certificate.
