13 The successful tenderer shall have to deposit 5% of the total tendered valve in the shape of "Deposit at

Call' in any Nationalized bank having branch at Jammu duly pledged to the Agriculture Chemist Talab-Tillo Directorate of Agriculture Jammu, as security money within the stipulated date given by the authority after acceptance of rate if the successful tenderer fails to deposit security money within the stipulated date, the tender shall be treated as invalid and rejected and earnest money deposited shall be forfeiting. Supply order will be issued on receipt of security money.

Security money will be released after completion of supply order. The Part of supply or incomplete

supply or deviation of specification will also invite forfeiting of security money.

- The successful tenderer shall have to supply the materials strictly within the time schedule to be given by the department. In case of failure to make the supply in time, the department shall be at liberty to arrange the same at the risk and cost of successful tenderer besides forfeiting the C.D.R, and initiating legal proceedings against the successful tenderer (s) as warranted under rules. In case, the extra cost involved exceeds the CDR amount, the same will be recovered from the defaulting supplier through Land Revenues Act. The decision of the Chairman D.L.P.C Agriculture department Jammu in this regard shall be final and binding upon the supplier. The supplier shall have no right to claim such refund at all.
- The Soil Health Card supplied if not found up to the standard specifications or any other shortcoming shall be rejected out rightly and shall have to be replaced by the supplier at their own cost and arrangements within seven days from the date of intimation.
