Sealed tenders affixed with revenue stamps worth Rs.5/- (Rs. Five only) are invited for and on behalf of Governor of J&K State from registered cold storage owners / dealers for providing cold storage facilities of seed potatoes at Jammu/suburb. Detail of terms and conditions is given below:

Approx. Area required: 500 Sq. meter, with open space having facilities of washing, processing, treatment, grading, labour operations, mechanical handling with grader the produce of seed potato before storage, moreover movement of trucks and trailers for unloading / loading.

To quote rate on per bag 50 Kg. Capacity or per square ft.

Terms and conditions

- 1** The tenders should reach the office of the undersigned by or before 16/09/2015 up to 02.00 P.M through speed post / courier/ by hand. Tenders brought by hand shall be put in a **TENDER BOX** by the concerned tenderer in the office of the undersigned on any working day during office hours up to the said date and time. In case of any gazetted holiday falling on the last date of receipt of tenders or some holiday suddenly declared by the competent authority under Negotiable Instrument Act, the next working day shall be treated as the last date of receipt of tenders
- 2** The tenders should be accompanied with a C.D.R./FDR for an amount of **Rs.15000/-**, on any scheduled bank and pledged to the Member Secretary, State Level Purchase Committee (S.L.P.C.), Department of Agriculture, J&K, Govt., Talab Tillo-Jammu.
- 3** The tenders should be neatly written in ink with rates in figures and words. Cutting or overwriting on quoted rates shall not be entertained unless authenticated. Cello tapes be applied on the written rates of tender.
- 4** Rates quoted must be inclusive of VAT/taxes
- 5** The successful tenderer shall have to enter into an agreement on judicial stamp paper of Rs.20 on prescribed Performa with the indenting officers before execution of job order.
- 6** In case of dispute the decision of Director Agriculture Jammu (Chairman SLPC) Shall be final and binding upon both the parties the Jurisdiction of legal litigation shall be the courts located at Jammu
- 7** Rates approved by State Level Purchase Committee shall remain valid up to one year from the date of issue of rate contract or the new rate contract is available.
- 8** Copy of electric tariff clearance ending July 2015, issued by Power Development Department shall have to be produced by successful tenderer before release of payment by Indenting Officer
- 9** The tenderer shall have to produce a copy of Commercial Tax Clearance certificate issued by the concerned assessing authorities for the period ending March 2015 along with tender documents or before finalization of the rates.
- 10** T.D.S as applicable under rule shall be deducted by Indenting Officer while making payment.
- 11** Approx. Area 500 Sq. meter, with open space having facilities of washing, processing, treatment, grading, labour operations, mechanical handling with grader the produce of seed potato before storage, moreover movement of trucks and trailers for unloading / loading.
- 12** Rate quoted should be for 50 Kg bag packing or per Sq. ft basis floor area
- 13** Tenderer will maintain :-
 - a) Temperature : Up to 2.4 degree Celsius to check respiration
 - b) Humidity : Above 95% to check shrinkage losses
 - c) Transformer facility : to provide adequate voltage supply

- d) Genset / Power backup : to provide during power shut down
- e) Safety and security : to be provided round the clock for safety of stocked materials of the department.
- f) Safety of seeds against rodents, pilferage and admixing with local materials to be ensured
- g) Department shall be at liberty for asking turning of bags at regular intervals as and when required without additional cost of turning.

14 A team of Agriculture Department shall be at liberty to visit cold storage for assessment of stock at any time.

15 In case of any loss i.e rotting and lanky sprouts due to temperature shocks, power failure in cold storage approved vendor shall be liable for such losses compensation besides facing legal procedure.


16 Approved tenderer will maintain record of daily temperature / RH and same make available during inspection or on demand of the department.

17 Tenderer will allow department team to inspect infrastructure before award of rate contract.

18 Payment shall be made on quarterly basis on submission of monthly rent bills.
