

The Release/revalidation of funds shall be subject to the following conditions:

- 1. All codal formalities as required under rules shall be adhered to strictly while implementing the programme.
- 2. The DDO's shall ensure that project wise accounts are maintained and are subject to normal process of statutory audit, an inventory of the assets created under the projects should be carefully preserved and assets that are no longer required shall be transferred to the Directorate for its use and re-deployment where ever possible.
- 3. The DDO's shall utilize the amount as per the approved Action plan of 2016-17.
- 4. The DDO's shall implement the programme/activity/components on the cost norms/guidelines/ subsidy component at par, which are admissible/permissible in the normal Centrally Sponsored Scheme implemented by the Departments for Paramparagat Krishi Vikas Yojana a component of NMSA.
- 5. The DDO's shall ensure that the funds released are utilized prudently are judiciously as per the guidelines of the scheme and in no case he should book the expenditure just for the sake of expenditure.
- 6. The DDOs shall restrict the expenditure to the actual availability of funds and no liability shall be created in any case.
- 7. The expenditure shall be incurred only after observing all codal formalities and in accordance with the guidelines of the scheme.
- 8. The DDO's shall ensure that there is no overlapping/duplication in adoption of Schemes/incurring of expenditure from any other scheme of the State or Central Government.
- 9. The DDO's shall ensure convergences of the scheme with other schemes in order to achieve the desired result.
- 10. The DDO shall ensure that funds revalidated should be utilized upto September 2017.
- 11. The DDO's shall furnish progress both in physical and Financial along with Utilization Certificate on monthly basis for its onward submission to Nodal Officer by or before 31..03.2017 for further submission to the Administrative Department.
- 12. Wherever Direct Benefit Transfer (DBT), is involved applicable guidelines including Aadhar Linkage shall be complied with strictly.
