Subject: - Compassionate appointment of Ms. Amarpreet Kour D/o Late Amarjeet Singh (Ex-PET), R/o Ward No. 08, Poonch City, Tehsil Haveli, District Poonch, under SRO-43 of 1994.

Whereas, Ms. Amarpreet Kour D/o Late Amarjeet Singh (Ex-PET), R/o Ward No. 08, Poonch City, Tehsil Haveli, District Poonch has been appointed as 'Mali' in the Pay Level-SL-I of Rs. 14,800-47,100 (equivalent to pre-revised pay scale of Rs. 4440-7440 + GP Rs. 1300/-) in the office of Chief Agriculture Officer, Poonch in District Cadre Poonch vide Govt. Order No. 151-JK (GAD) of 2020 dated 29-01-2020, under SRO-43 of 1994;

Whereas, the appointee was directed to report to the Directorate of Agriculture, Jammu vide aforementioned Govt. Order within a period of 21 days from the date of issuance of the Order;

And Whereas, Ms. Amarpreet Kour D/o Late Amarjeet Singh (Ex-PET) in pursuance of the said Govt. Order has reported in this Directorate on 01.02.2020;


Now therefore, it is hereby ordered that Ms. Amarpreet Kour is adjusted in the Office of Chief Agriculture Officer, Poonch against an available vacant post of 'Mali' and shall report to the Chief Agriculture Officer, Poonch alongwith following requisite certificates in original:-

1. Permanent Resident Certificate.
2. Academic Qualification Certificate.
3. Age & Health Certificate.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Any other Certificate as required under Rules.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police (CID), J&K.

If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order she shall forego her right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
