WHEREAS, 18 No. of *Halqa Panchayats*, whose area falls under District Samba are presently under the Administrative control of the Chief Agriculture Officer, Jammu. Likewise, 13 No. of *Halqa Panchayats*, whose area falls under District Jammu, are being presently administratively controlled by the Chief Agriculture Officer, Samba;

AND WHEREAS, it has been examined and found that the area of the *Halqa Panchayats* falling under the jurisdiction Districts of Samba and Jammu should be under the Administrative Control of the respective Chief Agriculture Officers and not otherwise as is the case at present in respect of aforementioned 18 *Halqa Panchayats* of District Samba and 13 *Halqa Panchayats* of District Jammu;

Now, in the above backdrop and in the interest of smooth administration, it is hereby ordered that the following mentioned *Halqa Panchayats* of the respective Districts of Samba and Jammu shall be under the Administrative Control of the Chief Agriculture Officers, Sub Divisional Agriculture Officers and the Agriculture Extension Officers as per the details mentioned against each:-
