On the recommendation of J&K Selection Board vide above referred letter No. and approval conveyed by the Administrative Department vide above referred letter No., sanction is hereby accorded to the temporary appointment of Shri Deepak Singh S/o Shri Ravi Singh R/o A/P Ward No. 49 Shanker Nagar Channi Rama, Jammu as Plant Protection Operator in the office of Sub Division Agriculture Officer, Billawar in the Pay Level -2 (19900-63200) District Cadre Kathua.

The appointee shall report to the Chief Agriculture Officer, Kathua within a period of 21 days from the date of issuance of this Order, If the candidate fails to Join within the stipulated time, he shall forego his right to appointment, and the same shall be deemed to have cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of following certificates/documents (in original) to be verified subsequently:

- 1) Academic/Technical Qualification Certificates.
- 2) Date of Birth Certificate.
- 3) Health Certificate issued by Chief Medical Officer
- 4) Domicile Certificate issued by the Competent Authority.
- 5) Certificate from the District Industries Centre (DIC) and District Employment & Counselling Centre to the effect that no loan under self-employment scheme has been taken by the appointee.

The appointment of the above candidate shall further be subject to the following conditions that:-

- a) The appointee shall give an undertaking in the shape of affidavit to the effect that if, on verification, genuineness of the certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against her/him.
- b) The appointee(s) shall give an undertaking that in the event of any adverse report received from CID, subsequently, the appointment of the appointee (s) shall be deemed to have been cancelled ab-initio.
- c) The appointee(s) shall be on probation for a period of two years.
- d) The inter-se seniority of the appointee shall be determined as the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
- e) The appointment of above candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
