On the recommendation of J&K Service Selection Board and approval conveyed by the Administrative Department, sanction is hereby accorded to the temporary appointment of Shri Aijaz Ahmed Mir S/o Gulam Rasool Mir R/o H.No.154 Chadoora, Budgam under RBA Category as Junior Assistant (District Cadre Rajouri) in the Pay Level-4 (25500-81100) in the O/o Area Development Officer (Veg), Rajouri.

The appointee shall report to the Chief Agriculture Officer, Rajouri within a period of 21 days from the date of issuance of this order, if the candidate fails to Join within the stipulated time, he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of following certificates/documents (in original) to be verified subsequently:

1. Academic/Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate issued by Chief Medical Officer
4. Domicile Certificate issued by the Competent Authority.
5. Reserved Category Certificate (in case of candidates belonging to reserved category)

The appointment of the above candidate shall further be subject to the following conditions that:-

- a) The appointee shall give an undertaking in the shape of affidavit to the effect that if, on verification, genuineness of the certificate(s) produced by the appointee is proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b) The appointee shall be on probation for a period of two years.
- c) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
- d) That, if the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment

Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- e) The appointment of above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
