The appointees shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:


1. Academic/Technical Qualification Certificates.
2. Matriculation / Date of Birth Certificate.
3. Health Certificate issued by concerned Chief Medical Officer of the District
4. Domicile Certificate issued by the Competent Authority.
5. Valid relevant Category Certificate (in case of candidates belonging to reserved category)

The appointment of the above candidates shall further be subjected to the following conditions that:-

- a) That, if the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary.

- DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- b) The appointees shall furnish an undertaking in the shape of an affidavit as per **Annexure-A** to the appointment order.
 - c) The salary of the appointees shall not be drawn and disbursed to them until and unless the satisfactory reports in respect of genuineness of qualification/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agencies.
 - d) The appointees shall be on probation for a period of two years.
 - e) The appointment of above candidates shall be governed by the "**New Pension Scheme**" as per SRO 400 of 2009 dated 24.12.2009.
 - f) The inter-se-seniority of the appointees shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
 - g) The appointment of the above appointees shall be cancelled ab-initio, if it is found that they possess higher qualification than the prescribed one at any stage and they shall also be liable for criminal prosecution under law.
 - h) The appointment of the above appointees shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
