In pursuance to G.O No. 512-JK(APD) of 2023 dated 10.10.2023 issued by Administrative Department, Sh. Bashir Ahmed Wani S/o Abdul Majid Wani R/o 136 Bathoie, Reasi, who has been temporarily appointed as "MTS" in the Pay Level SL-1 (Rs.14800-47100) in Agriculture Production and Farmers Welfare Department, Jammu under OM category has joined this Directorate on 13.10.2023, is hereby further adjusted as "**MTS**" against the available vacancy in the office of Chief Agriculture Officer, Reasi.

3. Health Certificate issued by concerned Chief Medical Officer of the District
4. Domicile Certificate issued by the Competent Authority.
5. Valid relevant Category Certificate (in case of candidates belonging to reserved category)

The appointment of the above candidate shall further be subjected to the following conditions that:-

- a) That, if the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- b) The appointee shall furnish an undertaking in the shape of an affidavit as per **Annexure-A** to the appointment order.
- c) The salary of the appointee shall not be drawn and disbursed to them until and unless the satisfactory reports in respect of genuineness of qualification/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agencies.

- d) The appointee shall be on probation for a period of two years.
- e) The appointment of above candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- f) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
- g) The appointment of the above appointee shall be cancelled ab-initio, if it is found that he possess higher qualification than the prescribed one at any stage and he shall also be liable for criminal prosecution under law.
- h) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
