The appointment of above mentioned candidate shall be subject to the following conditions that:-

- a) The salary of the appointee shall not be drawn and disbursed to him until and unless the satisfactory report in respect of genuineness of qualification/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agencies.
- b) The appointee shall be initially on probation for a period of two years.
- c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- d) If the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if
