- b) The appointee shall be initially on probation for a period of two years.
- c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.

She shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, in
