In pursuance to Government order No.481-JK (GAD) of 2024 Dated 25.01.2024 issued by General Administration Department J&K, Ms. Lovely Devi D/o Late Sardar Singh Ex-Assistant Lineman, Jal Shakti Department R/o Jankhar Tehsil Basholi District Kathua who has been temporarily appointed as **Class-IV/MTS** in the Pay Level-SL-I (14800-47100) in Agriculture Production and Farmers Welfare Department, District Cadre Kathua and has joined this Directorate on 12.02.2024, is hereby adjusted as MTS against available vacancy under control of chief Agriculture Officer, Kathua.

The appointee shall report to the Chief Agriculture Officer, Kathua alongwith the following original certificates / documents to be verified subsequently for further duties.

1. Permanent Resident Certificate/Domicile Certificate.
2. Academic Qualification Certificate / Date of Birth Certificate
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue)
5. Any other Certificate as required under rules.

The appointment of above mentioned candidate shall be subject to the following conditions that:-

- a) The salary of the appointee shall not be drawn and disbursed to her until and unless the satisfactory report in respect of genuineness of qualification/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agencies.
- b) The appointee shall be initially on probation for a period of two years.
- c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- d) If the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, She shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. She shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if

any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.

- e) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
