Whereas on the recommendations of J&K Service Selection Board vide letter No. JKSSB/23/2023-03 (E-7164134) dated 09.06.2023 and approval conveyed by the Administrative Department vide No. Agri/Cood/06/2021 (7091749) dated 20.06.2023 and after receipt of satisfactory report from J&K CID with regard to Character and Antecedents in favour of candidates those have filled their V-Roll, this Directorate vide Agriculture order No. 267-DAJ of 2023 dated 14.09.2023 had issued an appointment order in favour of 08 candidates for their temporary appointment as Junior Scale Stenographer, Division Cadre Jammu in the Pay Level-6B (35600-112800) in Agriculture Department with the directions to concerned appointees to report to their concerned officers within 21 days from date of issuance of above said appointment order, otherwise they shall forgo their right to appointment and their appointment shall be deemed to have been cancelled ab-initio without any further notice.

Whereas, the Chief Agriculture Officer Rajouri vide letter No. CAO/R/Estt/2023-24/3965 dated 17.10.2023 has conveyed that **Sh. Ajay Kumar S/o Krishan Lal** who was selected under **OM Category, Division Cadre Jammu** has not reported to this office till date to join as Jr. Scale Stenographer. Also, the Chief Agriculture Officer, Udhampur vide letter No. CAO/U/Estt/2023-24/4264 dated 14.10.2023 has conveyed that **Sh. Bunty Kumar S/o Sohal Lal** who was selected under **SC Category, Division Cadre Jammu** has not reported to this office till date to join as Jr. Scale Stenographer.

Whereas, the same has been conveyed to the Administrative Department vide letter No. Agri./DAJ/Estt-184/2023-24/4431 dated 28.10.2023.

Whereas, as per Circular No. 08 JK (GAD) of 2019 dated 04.12.2019 under endorsement No. GAD(Ser)Genl/Circ/06/01 dated 04.12.2019 issued by GAD, it has been provided that the candidates who failed to join within the period of 21 days from the date of issuance of the appointment order shall forgo their right to appointment which shall be deemed to have been cancelled ab initio without any further notice.

Now, therefore, keeping in view of above, the appointment of **Sh. Ajay Kumar S/o Krishan Lal** under OM Category, Division Cadre Jammu and **Sh. Bunty Kumar**

S/o Sohal Lal under SC Category, Division Cadre Jammu for the post of Junior Scale Stenographer in Agriculture Production & Farmers Welfare Department is deemed to have been cancelled ab-initio.
