On the recommendation of J&K Service Selection Board and approval conveyed by the Administrative Department vide above references, **sanction is hereby accorded to the temporary appointment of Shri Antish Sharma S/o Rajinder Kumar Sharma R/o Ward No. 7, Suketar Dansal 181221, Jammu as "Truck Cleaner"** under OM category in the Pay Level SL-2 (15900-50400) in Agriculture Production & Farmers Welfare Department District cadre Jammu against the available vacancy in the office of Farm Manager, Seed Multiplication Farm, Chinore.


The appointee shall report to **Joint Director of Agriculture (SLUB) Jammu** within a period of 21 days from the date of issuance of this order, if the candidate fails to join within the stipulated time, he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The appointee shall be allowed to join only on the production of following certificates/documents (in original) to be verified subsequently:

- 1) Academic/Technical Qualification Certificates.
- 2) Date of Birth Certificate.
- 3) Health Certificate issued by Chief Medical Officer
- 4) Domicile Certificate issued by the Competent Authority.
- 5) Reserved Category Certificate (in case of candidates belonging to reserved category)

The appointment of the above candidate shall further be subjected to the following conditions that:-

- a) The appointee shall give an undertaking in the shape of an affidavit to the effect that if, on verification, genuineness of the certificate(s) produced by him are proved to be fake or forged, the appointment shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b) The appointee shall be on probation for a period of two years.
- c) The inter-se-seniority of the appointee shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
- d) That, if the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
