In terms of J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22.02.1994, as amended from time to time and as per the approval conveyed by the Administrative Department vide above cited reference, sanction is hereby accorded to the temporary appointment of Sh. Vickey Kumar S/o Late Sh. Janak Raj (Ex- Helper) R/o Vill. Budhu Chak p/o Gajansoo Budhu Chak, Jammu as Multitasking Staff (MTS) District Cadre Jammu in the Pay Scale of SL-I (14800-47100) against an available vacancy in Seed Multiplication Farm, Chinore, District Cadre Jammu.

The appointee shall report to Joint Director Agriculture (SLUB), Jammu within a period of 21 days from the date of issuance of this order, failing which he shall forego his right to appointment and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:-



1. Academic Qualification Certificate / Date of Birth Certificate
2. Domicile Certificate.
3. Health Certificate from the concerned Chief Medical Officer of the District.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. Any other relevant documents as required under SRO-43/1994.

**The appointment of Sh. Vickey Kumar shall be subject to the following conditions that:-**

- a) The salary of the appointee shall not be drawn and disbursed to him until and unless the satisfactory report in respect of genuineness of qualification/Date of Birth/Relevant Category Certificate are received from the concerned Authorities/Agencies.
- b) The appointee shall be initially on probation for a period of two years.
- c) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- d) If the appointee fails to join within stipulated time as mentioned above shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- e) If the candidate has taken loan for self-employment from DIC/ Employment department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment Unit/enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMLs to be worked out by the DDO



- concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- f) The seniority of the appointee shall be determined as per the J&K Civil Service (Classification, Control & Appeal) Rules, 1956.
- g) The appointment of the above appointee shall be subject to the outcome of any writ petition(s) if any, pending before any court of competent Court of Law.
