She is directed to report to the Chief Agriculture Officer, Ramban for further duties. The Chief Agriculture Officer, Ramban shall allow the appointee to join only on production of following requisite documents/certificates (in original) to be verified.

- 1. Academic Qualification Certificate.
- 2. Date of Birth Certificate.
- 3. Domicile Certificate.
- 4. Health Certificate from the concerned Chief Medical Officer of the District.
- 5. Dependent Certificate issued by the Assistant Commissioner (Revenue).
- No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 7. All other relevant documents as required under SRO-43 of 1994.

## The above said appointment/adjustment of appointee shall further be subject to the following conditions:-

- a) That she shall give an undertaking in the shape of an affidavit to the effect that:
  - In case adverse report about her character and antecedents is received from the Inspector General of Police(CID), J&K, she shall have no right to claim her appointment as Class-IV (Khalasi) in Agriculture Production Department and her appointment as such shall be deemed to have been cancelled ab-initio;
  - If, on verification, genuineness of the qualification certificate from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV(Khalasi) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.
- b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) & (ii) above are received in her favour.
- c) The appointee shall be initially on probation for a period of two years.
- d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12.2009.
- e) If the appointee fails to join within stipulated time as mentioned in Government order she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
