In light of the revised procurement rate of Paddy Hybrid (DRH-834), the revised sale rate after allowing subsidy proposed by Joint Director Agriculture (Inputs) Jammu vide his letter No. Seed-6/2022-23/206-07 dated 20.04.2022 is also re-fixed as Rs. 24400 per qtl instead of Rs. 10200.00 per qtl.
