Whereas, Sh. Ravi Pandotra, JAEO (I/C RCO) was appointed in the department as JAA in the pay grade of Rs. 2000-200-3200 (pre-revised) vide Government order No. 191-Agri of 2004 dated 30.07.2004 and had joined the department on 02.08.2004 and subsequently in pursuant to the J&K Higher Standard Pay Scheme Rules, 1996 issued vide SRO-14 dated 15.1.1996, the 1st In-situ Promotion was granted in favour of Sh. Ravi Pandotra, JAEO (I/C RCO) w.e.f 01.09.2013 in the Pay Scale 9300-34800+4300 GP (Pre-Revised) Agri/DAJ/Estt/2012/3667-69 dated 07.09.2013.

Whereas, in light of order/judgment dated 29.12.2021 passed by the Hon'ble Central Administrative Tribunal Jammu Bench O.A 61/151/2021 titled Ravi Pandotra V/s Union Territory of J&K and others, the Administrative Department vide Government order No.01-JK(APD) of 2022 dated 10.05.2022 has 09.04.1997 and monetarily with effect from 30.07.2004 (date of his appointment) in the pay grade of Rs. 2000-200-3200 (pre-revised).

Whereas, Sh. Ravi Pandotra, JAEO (I/C RCO) vide his application dated 27.05.2022 has requested this Directorate for grant of necessary change in date of 1st in-situ promotion as the same is due in his favour requested for grant of 2nd Insitu Promotion w.e.f 01.05.2015 in his favour.

Whereas, the application of Sh. Ravi Pandotra, JAEO (I/C RCO) for review of time bound promotions in favour of in light of above Govt. order dated 10.05.2022, has been routed to this Directorate through concerned controlling officer alongwith all requisite formalities required for issuance of necessary SRO-14 dated 15.1.1996 under rules.

Whereas the case has been reviewed and it has been observed the case of Sh. Ravi Pandotra, JAEO (I/C RCO) is genuine and entitled for revision in date of his 1st In-Situ Promotion and accordingly entitled for 2nd In-situ Promotion with respect to corresponding date of his 1st in-situ promotion.

Therefore, in view of above, sanction is hereby accorded to the revision in date **in-situ promotions** (1st & 2nd) and its benefits thereof in favour of Sh. Ravi Pandotra, JAEO (I/C RCO) of the office of CAO Jammu under J&K Higher Standard Pay Scale Scheme Rules, 1996 issued vide SRO-14 dated 15.1.1996 from the dates and pay scale mentioned hereunder in light of revision in date of 1st Appointment of the incumbent. This however shall be subject to the following terms and conditions as laid down in the aforesaid SRO to be examined by the concerned Drawing and Disbursing Officer:-

- That the employee availing the benefit shall give an undertaking to the Drawing and Disbursing Officer to the effect that as and when he/she will be eligible for functional promotion, he/she will 2.
- That no higher standard pay scale shall be allowed to the employees who are under suspension on the date of eligibility or who is charge sheeted under provision of J&K Classification, Control and Appeal Rules or any other rules for the purpose. 3.
- That such period of leave without allowance as had not been agreed to by the competent authority to be counted for purpose of annual increments shall not be taken into account for rendering of the period of 9/18/27 years for higher standard pay scales as the case may be.

That the services of surplus employees due to discontinuance/abolition of posts in the former

That the benefit of promotion shall not be given relinquishes/relinquished promotion for reasons what so ever. 6.

That the Drawing & Disbursing Officers shall only allow the benefit of In-Situ promotion to those persons, who had not availed the benefit of three promotions including functional promotion, if 7:

The benefit of promotion in-situ shall be subject to further verification from the original record by the concerned Drawing & Disbursing Officer.

The benefit of In-Situ promotion shall not be allowed to the persons who are involved in misappropriation, mis-conduct, embezzlement/corruption, retention of Govt. money or there is pending disposal the enquiry in the Department against the official.

It shall be ensured by the concerned Drawing and Disbursing Officer that the officials enlisted in the Annexure are due for In-Situ promotion as per standing norms/rules.

10. That the employee has furnished an affidavit that in case he is confirmed on Gazetted Cadre post before the grant of the above In-situ Promotion, he shall bound to refund the benefit of such
