6. The copy of the seniority list duly signed by each of the officials who have no objection to it be furnished to this Directorate, and;
7. The objections received after the stipulated date shall not be considered.

Whereas, no any objection was received against the said seniority within the stipulated time and accordingly the Final Seniority list of Junior Assistants of Doda District was issued vide this office Order endorsement No: Agri/DAJ/Estt-75/Seniority/2020/ 1835-36 dated 31.01.2020 for filing appeal to the competent authority if any person is aggrieved with the seniority position;
