The deputation shall inter-alia be subject to the following conditions:-

1. The period of pursuing diploma in Agriculture BAT may be treated as study leave in terms of Jammu and Kashmir Service (Leave) Rule , 1979 read with SRO 274 (Rule 67(2) (a) dated 30.05.2013.
2. The selected candidates will execute agreement/bond with the concerned Head of Departments undertaking therein that they will serve the

Department at least for eight years after completion of the said training course.

3. On completion of course of the study, the Government servant shall submit the certificate of examination passed or special course of study undertaken indicating the date of commencement and termination of the course to the Administrative Department through concerned Head of the Department.
4. The Head of the Department shall submit a copy of relieving order to the Administrative Department ; and
5. The said course will not confer any right to preferential claim for their out of turn promotion or any other claim in contravention.
6. The officials in respect of whom relaxation has been granted in length of service shall submit an undertaking duly authenticate by 1st Class Magistrate, wherein they affirm that they will not claim any promotion prospects unless and until they become eligible in terms of guidelines framed vide Government Order No.68-Agri of 2016 dated 29.09.2016.
