**Subject:-** Compassionate appointment of Shri Asif Sajad S/o Late Shri Abdul Guffar, Ex-Field Assistant-II R/o Matlote Tehsil Thuroo District Reasi under SRO 43 of 1994.

In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43, dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Shri Asif Sajad S/o Late Shri Abdul Guffar, Ex-Field Assistant-II R/o Matlote Tehsil Thuroo District Reasi, as 'Agriculture Oversear/equivalent' on compassionate grounds in the Pay level-2 (Rs 19900-63200) equivalent to the pay scale of Rs.5200-20200/- + G.P Rs.1900 (PR) on compassionate grounds against available vacancy in the office of the Chief Agriculture Officer, Reasi.


The appointee shall report to the Chief Agriculture Officer, Reasi within 21 days from the date of issuance of this Order for further duties alongwith the following mentioned original certificates / documents to be verified subsequently. In case, he does not join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any further notice.

1. Permanent Resident Certificate.
2. Academic Qualification Certificate.
3. Age & Health Certificate.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. No loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Any other Certificate as required under rules.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, (CID), J&K.
