Subject:- Compassionate appointment of Smt. Rukhsar Akhter W/o Late Shri Subash Chander, Ex-Junior Agriculture Extension Officer R/o Kawa Udhampur under SRO-43 of 1994.

In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43 dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Smt. Rukhsar Akhter W/o Late Shri Subash Chander, Ex-Junior Agriculture Extension Officer R/o Kawa Udhampur as 'Plant Protection Operator/Equivalent' in the Pay level-2 (Rs 19900-63200) equivalent to the (pay scale of Rs.5200-20200/- + G.P Rs.1900(PR), on compassionate grounds against available vacancy in the office of the Chief Agriculture Officer, Udhampur.

The appointee shall report for further duties to the Chief Agriculture Officer, Udhampur within 21 days from the date of issuance of this order alongwith the following mentioned original certificates / documents to be verified subsequently. In case, she does not join within the stipulated period, her appointment shall be deemed to have been cancelled ab-initio without any further notice.

2. Academic Qualification Certificate.
3. Age & Health Certificate.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. No loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Any other Certificate as required under rules.

The appointee shall be initially on probation for a period of two years. If, on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-intio.

The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, (CID), J&K.
