Security deposit remains valid for a period of 04 months or successful completion of the contract. The Security Deposit (as performance Security) shall be returned to the supplier after the expiry of the contract period on furnishing usual clearance/No Demand Certificate.
- **ARBITRATION** :- In case of dispute of any nature arising while allotting the contract, the matter shall be referred to the Director Agriculture Jammu whose decision as arbitrator shall be final and binding upon the both the parties. In case the matter cannot be resolved amicably the filing of case by the contractor shall be subject to the jurisdiction of courts of the J&K.
