- 6) I shall file a separate MOI for each place when the business of selling Seeds is intended to be carried on at more than one place.
- 7) I shall file separate MOI to carry on the business of Seeds both as retail and wholesale dealer.
- 8) I confirm that my previous certificate of Registration or Authorization is not under suspension or Cancellation or debarred from selling of Seeds.
- 9) License shall be displayed at a prominent and conspicuous place in a part of the business premises open to the public.
- 10) The license comes into force with immediate effect and shall be valid for a period of 3 years unless previously cancelled or suspended. The renewal will be after a period of three years under rules.
- 11) The licensee shall give facility to the licensing authority or any other officer acting under his authority for the purpose of inspecting his stock in any shop, depot or godown or other place/places used by him for the purpose of storage, sale or export of seeds.


