
In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43, dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mtr. Shamim Akhtar, W/o Late Shri Manzoor Hussain, (EX AEO) R/o Ndiyan, Tehsil Darhal, District Rajouri, as 'Junior Assistant' on compassionate grounds in the Pay Level-4 of Rs. 25,500-81,100 (equivalent to the pay scale of Rs. 52,00-20,200/- + G.P Rs. 2400/ PR) against available vacancy of 'Junior Assistant' in the office of the Chief Agriculture Officer, Rajouri. The appointment, however, shall be subject to the passing of type speed test of 35 words/ minute by the candidate, to be conducted by the Department within two months.

The appointee shall report to the Chief Agriculture Officer, Rajouri alongwith the following original certificates / documents to be verified subsequently for further duties within 21 days from the date of issuance of this Order. In case, she does not join within the stipulated period, her appointment shall be deemed to have been cancelled ab-initio without any further notice.

1. Permanent Resident Certificate.
2. Academic Qualification Certificate.
3. Age & Health Certificate.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Any other Certificate as required under rules.

The appointee shall be initially on probation for a period of two years. If, on verification at any stage, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.


The salary of the appointee shall not be drawn and disbursed to her unless she passes the type speed test and a satisfactory report about the verification of her character and antecedents is received from the Inspector General of Police, CID, J&K.
