Subject:- Compassionate appointment of Ms. Taniya Mehra D/o Late Shri Vipan Kumar, Ex-Orderly R/o Sector 3, Bhagwati Nagar Jammu under SRO-43 of 1994.
Reference: Certificate issued by Deputy Commissioner, Jammu under SRO-120 of 2018, dated 05.03.2018 vide No. DCJ/Relief/SRO-120/2019-20/28-29 dated 25.10.2019.

In terms of the J&K Compassionate Appointment Rules, 1994, notified vide SRO-43, dated 22.02.1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Ms. Taniya Mehra D/o Late Shri Vipan Kumar, Ex-Orderly, R/o Sector 3, Bhagwati Nagar Jammu, as 'Orderly' in the Pay Level-SL I of Rs.14,800-47,100 equivalent to the (pay scale of Rs.4440-7440/- + G.P Rs.1300/ PR) on compassionate grounds against available vacancy in the office of the Potato Development Officer, Jammu.


The appointee shall report to the Potato Development Officer, Jammu alongwith the following mentioned original certificates / documents to be verified subsequently for further duties within 21 days from the date of issuance of this Order. In case, she does not join within the stipulated period, her appointment shall be deemed to have been cancelled ab-initio without any further notice.

2. Academic Qualification Certificate.
3. Age & Health Certificate.
4. Dependent Certificate issued by the Assistant Commissioner (Revenue).
5. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
6. Any other Certificate as required under rules.

The appointee shall be initially on probation for a period of two years. If, on verification at any stage, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.


The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report about the verification of his character and antecedents is received from the Inspector General of Police, (CID), J&K.
